1. The proposed Findings of Fact and Conclusions of Law for the Big Porcupine Project Permit were due to the Environmental Quality Council on Wednesday, October 11, 2006.
2. In drafting the proposed Findings of Fact and Conclusions of Law, counsel for Bill Barrett Corporation determined that a hearing transcript would be necessary to verify the proposed findings and conclusions.
3. The hearing transcript has not yet been provided to counsel for BBC.


