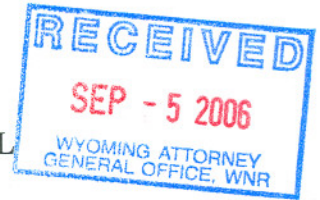

**STIPULATION ON EXHIBITS**


