<u>Area in Johnson County, September 23, 2004</u>" and related public comments that the above referenced drainages, including the mapped and unmapped tributaries, are most appropriately classified as Class 4B, with the exception of the mainstem segments of Cat Creek and Fourmile Creek as described above which are most appropriately classified as Class 4C. All of these Class 4 drainages will be protected for recreation, wildlife, agriculture, industry and scenic value use

This decision is considered a final action of the administrator of the Water Quality Division and may be appealed pursuant to Chapter 1, Section 16 of the Rules of Practice and Procedure. The reclassification of these eight drainages to the Powder River and their tributaries shall also be submitted to the U.S. Environmental Protection Agency for approval as revised water quality standards for Clean Water Act purposes.
