PRE-HEARING DISCLOSURES

Pursuant to the Environmental Quality Council's (Council) Final Scheduling Order the Department of Environmental Quality, Water Quality Division (Division), through the Office of the Attorney General, hereby submits its Pre-Hearing Disclosures.

SUMMATION OF THE FACTS

The Division issued Wyoming Pollutant Discharge Elimination System (WYPDES) permits WY0052817 and WY0052833 to Kennedy Oil on November 30, 2005. Permit number WY0052817 allowed Kennedy to discharge 1.21 million gallons of produced water from coal bed methane wells to various named, on-channel reservoirs located on various unnamed ephemeral tributaries of Plosser Draw and Indian Creek. Indian Creek is a tributary to the Powder River. Permit number WY0052833 allowed Kennedy to discharge 2.55 million gallons of produced water from coal bed methane production to various on-channel reservoirs located on McCray Craw, Timber Draw, Morris Draw and unnamed ephemeral tributaries of Crazy Woman Creek. These streams are all tributaries to

the Powder River via Crazy Woman Creek. Both permits require that the produced water

originate in the Big George coal seam.

Adami Ranch, LLC of Buffalo, Wyoming timely filed a Petition for Review, Notice

of Appeal and Request for Contested Case Hearing with the Council on February 1, 2006.

Adami's petition contends that Kennedy's permit application:

1. falsely states that Kennedy and Adami Ranch reached an agreement with regard

to the discharge of produced water over Adami Ranch,

2. the volume of produced water will cause accelerated erosion on Adami Ranch,

3. the application does not address the impact of produced water on livestock

production,

4. that water infiltrating from the containment ponds through an unsaturated zone will

result in violation of ground water standards,

5. monitoring wells are not sufficient, that the application is inconsistent with the plan

of development submitted to the Bureau of Land Management,

6. there is no easement for the conveyance of produced water across Adami Ranch,

and

7. cumulative effects of all Coal Bed Methane projects has not been studied for the

entire Indian Creek area.

Since the filing of the Petition for review, Kennedy was purchased by Lance Oil &

Gas Company, Inc., and Lance Oil & Gas has been purchased by Anadarko Petroleum

Corporation.

Whether WYPDES permits WY0052817 and WY0052833 were issued to Kennedy Oil by the Division in compliance with Wyoming law. The Division's position is that the discharge permits were issued in full compliance with Wyoming law.
