ORDER ADDING ITEM TO SCHEDULING CONFERENCE ORDER

The Wyoming Environmental Quality Council's (Council) Scheduling Conference Order, dated May 29, 2007, filed June 5, 2007, in the above-captioned matter directs that all discovery, both written and oral, shall be completed by November 1, 2007. On June 8, 2007, the Wyoming Department of Environmental Quality (DEQ) filed a request to add the following item to the schedule set forth in the Council's Scheduling Conference Order:


By August 1, 2007, the parties shall designate all expert witnesses they will or may call to testify at the hearing, and for each expert witness list his/her credentials and publications and identify the subject matter, opinions and grounds for each opinion to which the expert will testify.

Chapter II, Section 10(b) of the DEQ Rules of Practice & Procedure provides that the Council may govern the conduct of discovery and the time limitations involved. Having considered this request and its compatibility with the schedule set forth in the Council's Scheduling Conference Order,

ORDER ADDING ITEM TO SCHEDULING CONFERENCE ORDER

IT IS ORDERED that, in addition to the items set forth in the Council's Scheduling Conference Order, the parties shall, by August 1, 2007, designate all expert witnesses they will or may call to testify at the hearing, and for each expert witness list his/her credentials and publications and identify the subject matter, opinions and grounds for each opinion to which the expert will testify.


