AMENDED ORDER TO RESCHEDULE PREHEARING CONFERENCE

THIS MATTER, having come before the Environmental Quality Council pursuant to the Joint Stipulation filed by the Parties on October 31, 2007, and the Presiding Officer being fully advised in the premises;

IT IS HEREBY ORDERED that:


1. The Prehearing conference scheduled herein for December 3, 2007, is vacated and rescheduled to take place on January 9, 2008, at 1:30 p.m. by conference telephone call. The conference call shall be set-up by the staff of the Environmental Quality Council. The purpose of the Prehearing is:

- a. Identification of witnesses, their addresses, phone numbers, and the substance of their proposed testimony;
- b. Clarification of the legal issues, both substantive and procedural, of all the parties, including identification of the statutory provisions and regulations that form the basis of the appeal;
- c. Stipulation to uncontested facts;
- d. Examination and marking of proposed exhibits and entering into stipulations to the foundation and admissibility of the exhibits and testimony; and
- e. Pending motions.

2. The Parties shall file with the Council and deliver to each other Prehearing Memorandums on or before January 4, 2008. At a minimum the Memorandums shall identify the issues of the hearing, will-call and may-call witnesses, exhibits and any other matters the Parties need to have considered at the Prehearing Conference.

3. The Parties shall exchange and submit 3 copies to this office of all exhibits on or before the Prehearing Memorandum due date, January 4, 2008 and shall be prepared to discuss and enter into stipulations regarding the foundation and admissibility.


