**JOINT STIPULATION TO EXTEND DISPOSITIVE MOTION  
DEADLINE**

Petitioners Yates Petroleum Corporation (Yates), Marathon Oil Company (Marathon) and Citation Oil & Gas Corp. (Citation), collectively Yates, et al, Petitioner Wyoming Outdoor Council (WOC) and Respondent Wyoming Department of Environmental Quality (WDEQ), the only Parties in the above-captioned consolidated contested case before the Wyoming Environmental Quality Council (Council), jointly stipulate as follows:

1. The Council's "Order on Consolidation of Cases and Continuance of Hearing" dated and filed October 4, 2007 rescheduled the hearing in this matter from December 17-21, 2007 to January 28-February 1, 2008, and provides for the Parties to submit a Stipulation and Conforming Order if they desire to extend or modify any of the deadlines or cut-off dates set forth in the Scheduling Orders and Amended Scheduling Conference Order entered in Docket Nos. 06-3815, 06-3816 and 06-3817.
2. The Scheduling Conference Order, dated May 29, 2007 and filed June 5, 2007, in Docket No. 06-3815 sets a deadline for dispositive motions on or


before November 16, 2007. The same Order sets a deadline for responses to dispositive motions on or before November 30, 2007.

3. There is no similar dispositive motion deadline (other than the July, 2007 deadline for WOC's Motion for Summary Judgment) in the Scheduling Conference Orders, dated May 29, 2007 and filed June 5, 2007, in Docket Nos. 06-3816 and 06-3817.
4. The Parties jointly stipulate and request that the Council extend the dispositive motion deadline set forth in the Scheduling Conference Order for Docket No. 06-3815 to December 14, 2007.
5. The Parties jointly stipulate and request that the Council extend the deadline for responses to dispositive motions set forth in the Scheduling Conference Order for Docket No. 06-3815 to December 28, 2007.
