PETITION FOR LEAVE TO INTERVENE IN WYOMING OUTDOOR COUNCIL APPEALS OF PUMPKIN CREEK GENERAL PERMIT, PERMIT NUMBER WYG280000, AND WILLOW CREEK GENERAL PERMIT, PERMIT NUMBER WYG290000

Pursuant to the Wyoming Department of Environmental Quality ("DEQ") Rules of Practice and Procedure, Chapter 2, Section 7, Yates Petroleum Corporation, Marathon Oil Company and Citation Oil & Gas Corp. ("Intervenors") hereby file this Petition for Leave to Intervene and respectfully request that the EQC allow intervention in the above-captioned petitions filed by Wyoming Outdoor Council ("WOC").

## **INTERVENORS**

- 1. Intervenors own and operate coal bed natural gas facilities located in watersheds subject to the General Permits. These facilities are currently permitted under individual permits authorizing discharge of produced water to several on-channel reservoirs located on various unnamed ephemeral tributaries of the watersheds in the Powder River Basin. Discharges of coal bed natural gas produced water in these watersheds are the subject of the General Permits.

3. Intervenors in this matter are represented by Eric L. Hiser and Matthew Joy, of Jorden Bischoff & Hiser, P.L.C., 7272 East Indian School Road, Suite 360, Scottsdale, Arizona, 85251. Correspondence and information related to this Motion should be served on Intervenors' counsel and on the company contacts at the addresses above.

#### INTERVENOR'S RIGHTS AFFECTED

- 4. Intervenors' discharges in connection with production of coal bed natural gas are (or will be) regulated by the Wyoming Department of Environmental Quality's Water Quality Division ("WWQD") under the subject General Permits, if finally issued, therefore, Intervenors have a legal right to intervene.
- 5. While Intervenors are currently operating under individual permits, the individual permits will expire in the future and at least some of the Intervenors' discharges are (or could become) subject to the terms and conditions set forth in the General Permits.
- 6. Further, Intervenors are indispensable parties to the above-captioned petition. Intervenors claim an interest relating to the subject of this action and are so situated that EQC's disposition of the action in absence of Intervenors may impair or impede the Intervenor's ability to protect their interests. *See* Wyoming Rules of Civil Procedure 19(a), 24(a).
- 7. The Intervenor's interests are not adequately addressed by either of the existing parties to the above-captioned appeal. Intervenors' interests will be directly and adversely affected by the outcome of this proceeding should EQC grant WOC's sought-after relief and determine that the General Permits are null and void and/or determine that DEQ cannot issue general permits.
- 8. In the alternative, if the issuance of the permits is upheld, any changes resulting from this appeal without Intervenor's participation would directly and adversely affect the rights of Intervenors to discharge as provided under the Wyoming Environmental Quality Act.

# REQUEST FOR RELIEF

9. For all of the foregoing reasons, Intervenors respectfully request that the EQC grant Intervenor's Petition for Leave to Intervene.

- 10. Intervenors acknowledge the EQC's set schedule regarding WOC's Motion for Summary Judgment and do not intend to change the scheduled Summary Judgment filing deadlines or hearing date.
- 11. Intervenors will file separately its Response in Opposition to WOC's Appeals of the Pumpkin Creek and Willow Creek General Permits in the event the Council grants this request to intervene.
