Petitioners Yates Petroleum Corporation, Marathon Oil Company and Citation Oil and Gas Corp., collectively "Petitioners," pursuant to the Environmental Quality Council's (the Council's) Pre-Hearing Conference Order, dated January 15, 2008, hereby submit this request for Clarification regarding that Order.

- 1. During the Pre-Hearing Conference, the parties discussed the issues to be considered by the Council at the hearing.
- 2. In their Pre-Hearing memorandum, dated January 4, 2008, Petitioners identified as one issue: "Are the effluent limits applicable to Category IC discharges located above irrigation for EC and SAR water quality based?"
- 3. At the Pre-Hearing Conference, all Parties (WDEQ, Petitioners and the Wyoming Outdoor Council) stipulated that the effluent limits applicable to

Category IC discharges located above irrigation for EC and SAR are water quality based effluent limits.

4. The Pre-Hearing Conference Order includes stipulations concerning exhibits but does not mention or otherwise allude to the above stipulation.

Wherefore, Petitioners respectfully request that the Pre-Hearing Conference Order be revised (or amended) to include the above-mentioned stipulation.
