RESPONDENT DEQ'S SUPPLEMENTAL MEMORANDUM CONCERNING ISSUES OF FACT FOR WOC'S MOTION FOR SUMMARY JUDGMENT

Respondent Wyoming Department of Environmental Quality (DEQ), pursuant to Rules 6(c)(1) & 56(c) of the Wyoming Rules of Civil Procedure and Chapter II, Section 14 of the DEQ Rules of Practice & Procedure, submits the following supplemental memorandum concerning issues of fact for Petitioner Wyoming Outdoor Council's (WOC) motion for summary judgment in the above-captioned consolidated case before the Wyoming Environmental Quality Council (Council).

WOC correctly points out that the three legal issues identified in its motion are "susceptible to resolution by summary judgment" if there are no material issues of fact in dispute. WOC Reply Br. at 1; Wyo.R.Civ.P. 56(c). Respondent DEQ has agreed all along that these three issues should be appropriate for resolution by summary judgment. In order for that to remain the case, it is necessary to keep this debate free of issues of fact. If the material facts which are truly undisputed can be kept that way, then the parties can argue

about how the law applies and the Council can draw their own conclusions. WOC states that "all parties apparently agree that there are not genuine issues of material fact in dispute." WOC Reply Br. at 1. This supplemental memorandum addresses the following two factual contentions in WOC's initial and reply briefs which go beyond the undisputed material facts regarding the issue of statutory authority for general permits.

- 1. 2007 HB 0212 was introduced as "AN ACT relating to environmental quality; clarifying general watershed permits relating to coal bed methane production; and providing for an effective date" and amending W.S. 35-11-302(a)(v). (DEQ Ex. E). HB 0212 was not enacted into law during the 2007 Legislative Session, and W.S. 35-11-302(a)(v) was left unchanged. Those facts are not disputed. However, WOC goes further by contending that:
 - "the Wyoming legislature said 'no thanks" to 2007 HB 0212. (WOC Reply Br. at 6);
 - 2007 HB 0212 "died an ignominious death" (WOC Br. at 11);
 - the fact that 2007 HB 0212 was not enacted into law is an "unequivocal expression of legislative intent" (WOC Br. at 11-12);
 - "[t]he legislative intent is clear" (WOC Br. at 13).

The documented facts are these:

- During the 2007 Legislative Session, there were 323 House Bills introduced, of which 128 (40%) ultimately were passed by both the House and Senate. 2007 General Session Bill Statistics (attached hereto as DEQ Ex. G).
- HB 0212 was introduced and referred to House Committee H09, which recommended its passage by a unanimous vote of 8-0 (with 1 excused). 2007 General Session-Journal Digest-HB0212 (attached hereto as DEQ Ex. H).

- HB 0212 was placed on General File in the House and passed Committee of the Whole and 2nd and 3rd Readings by a final vote of 42-18. (DEQ Ex. H).
- HB 0212 was introduced and referred to Senate Committee S09, but was not reported out of committee by the cutoff date. (DEQ Ex. H).
- 68 total recorded votes were actually cast on HB 0212, of which 50 were in favor and 18 were opposed. (DEQ Ex. H).
- The ultimate fate of HB 0212 was not the result of a straight up or down vote in the Legislature. (DEQ Ex. H).

Calling this "an ignominious death," an "unequivocal expression of legislative intent" and the Wyoming Legislature saying "no thanks" to 2007 HB 0212 does not comport with the documented facts for purposes of WOC's pending motion for summary judgment.

2. Respondent DEQ cited Wyoming Supreme Court decisions to point out that the Legislature's knowledge of the Council's and DEQ's interpretation of authority for general NPDES permits based on W.S. 35-11-302(a)(v) can be implied from the combined 16 year history of Ch. 18 (1991) and Ch. 2 (2004). DEQ Br. at 12. In particular, legislative knowledge may be implied by virtue of the promulgation of written regulations. *Town of Pine Bluffs v. State Bd. of Control*, 647 P.2d 1365, 1367 (Wyo. 1982). DEQ Br. at 12.

Contrary to Wyoming case law (DEQ Br. at 12), WOC "reject[s]" the "idea that the 16-year history of regulations" governing DEQ issuance of NPDES general permits "implies legislative consent or authorization" for NPDES general permits. WOC Reply Br. at 6. WOC makes the factual allegation that "[t]he most likely probability is that the Wyoming legislature was not alerted to the general permit issue for water quality permits until this last

[2007] legislative session." WOC Reply Br. at 6. This allegation is not consistent with the following undisputed facts:

- WWQR&R Chapter 18, which initially prescribed the process for DEQ issuance of NPDES general permits, was adopted by the Council as a rule in 1991. (DEQ, Ex. A).
- The general permit provisions of Chapter 18 were incorporated into current Chapter 2 by rule adopted by the Council in 2004. (DEQ Ex. C).
- Chapter 18 (DEQ Ex. A) and current Chapter 2 (Section 1(a)) both specifically cite W.S. 35-11-302(a)(v) as statutory authority for NPDES general permits.
- W.S. 35-11-1002 requires that any rule promulgated under the Wyoming Environmental Quality Act (WEQA) shall be published and distributed to members of the Legislature.
- W.S. 16-3-103(a)(i) requires that an agency shall give notice of proposed rules to the legislative service office (LSO).
- "[T]he legislative management council must be given a chance to review the proposed rule." WOC Br. at 5.
- "The legislative service office must be provided a copy of the rule adopted by the EQC." WOC Br. at 5.
- Notice of intended rulemaking for WWQR&R Chapter 2 and the proposed rule in strike and underscore format were provided to the LSO on July 13, 2004. November 10, 2004 Secretary of State file-stamped Certification Page for WWQR&R Chapter 2 (attached hereto as DEQ Ex. I).
