



The Parties should be prepared to discuss whether the cases should be consolidated or whether one of the cases is representative of all of the issues raised in the other proceedings and thus should be expeditiously brought to a hearing and decided by the Council. In addition, the Parties should be prepared to discuss a discovery schedule, hearing dates and associated matters.
