

**ORDER GRANTING JOINT MOTION TO STAY PROCEEDINGS PENDING  
SETTLEMENT DISCUSSIONS**

Petitioner, Yates Petroleum Corporation (Yates), and Respondent, the Department of Environmental Quality (DEQ), the only Parties to this appeal, filed a Joint Status Report and Motion to Stay Proceedings on August 13, 2008, requesting that the Environmental Quality Council (EQC) continue these proceedings for an additional thirty (30) days, until September 12, 2008, in order to facilitate possible settlement as explained in their joint motion. Chapter I, Section 10(b) of the DEQ Rules of Practice & Procedure provides that the EQC may grant continuances for good cause shown. Chapter I, Section 11 of the DEQ Rules of Practice & Procedure provides for informal disposition of cases by settlement or stipulation, upon approval of the EQC. Having considered the Parties' Joint Motion and, in reliance thereon, finding good cause for the requested 30 day continuance,

IT IS HEREBY ORDERED that the Parties Joint Motion for Stay is granted, and not later than September 12, 2008 the Parties shall notify the EQC that they either have reached agreement for dismissal of Yates' pending appeal or request a scheduling conference to set the matter for hearing.


