4. Examination and marking of proposed exhibits and entering into stipulations to the

foundation and admissibility of the exhibits and testimony.

5. Pending motions.

Final hearing in this matter is scheduled for November 16, 17 and 18th, 2010. Said hearing shall

be held in Laramie Wyoming at the University of Wyoming. The exact location shall be

finalized at a later date. The hearing shall start at 9:00 a.m. on November 16, 2010.
