If the Parties do not file a waiver to this section, the Parties should equally pay the costs of the transcript.

IT IS HEREBY ORDERED

- The Parties shall appear for a short pre-hearing conference in this matter that will he conducted on Monday, April 20, 2009 at 9:00 a.m. via telephone conference call. The parties shall inform the EQC office of a telephone number where they can be reached for the pre-hearing on or before April 15, 2009. Failure to appear at the pre-hearing conference will result in dismissal from this case.
- If the Parties have not filed a waiver on or before April 15, 2009 a court reporter will transcribe the hearing.
- Each party shall assume one third of the cost of the transcript and court reporter.
