ON THE 16TH DAY OF SEPTEMBER, 2009 at 9:00 a.m. the above entitled matters came on for scheduling conference before the Presiding Officer for the Council, Dr. Fred Ogden.

Present were Kate Fox and Mark Stewart, counsel for the Petitioner; Mike Barrash, Pete

Michael and Luke Esch, Asst. Attorney Generals on behalf of the Department of Environmental Quality and William Sparks and Mike Wozniak on behalf of Cedar Ridge LLC.. Also present for the conference was James Ruby, Exec. Secretary for the Council, and Joe Girardin the Council's paralegal.

On September 14, 2009 the Respondent filed a motion to continue the scheduling conference. On September 15, 2009 the Petitioner filed a response in opposition to the motion to continue. The Presiding officer received oral arguments on September 16, 2009 regarding the motion to continue. Being fully advised, the Motion of the Respondent is denied.

Discussion was held by the parties and the Presiding Officer and the following was agreed to by the Parties and is hereby made the Order of the Council:

1. All non-expert written and oral discovery shall be completed by November 2, 2009.

- The Petitioner shall file their Expert Designations and Reports by November 2, 2009.
   The report shall state the credentials and opinion(s) of each expert and contain a detailed summary of the facts and analysis that supports each opinion.
- 3. The Respondent and Third Party Respondent shall file their Expert Designations and Reports by December 1st, 2009. The report shall state the credentials and opinion(s) of each expert and contain a detailed summary of the facts and analysis that supports each opinion.
- Depositions including Depositions of Experts and Written Discovery of Experts shall be concluded by January 25<sup>th</sup>, 2010.
- 5. Any Dispositive Motions shall be filed by February 9th, 2010
- 6. Replies to Dispositive Motions shall be filed by February 23<sup>rd</sup>, 2010
- Hearing on any Dispositive Motions shall be heard on March 11th, 2010. The hearing shall be held in Cheyenne Wyoming.
- 8. A prehearing conference shall be held, if necessary, on April 14th, 2010.
- Final Hearing on the matter shall be held on May 12<sup>th</sup>, 13<sup>th</sup>, and 14<sup>th</sup> 2010. The hearing shall be held in Cheyenne Wyoming.
- 10. All filings shall be made no later than 12:00 p.m. on the date set forth in this Order.
