Grassland Mobile Home Park - Construction and Operation of a Public Water Supply System and Sewerage System without permits and discharging wastes without a permit

Lady and Gentlemen:

Enclosed is a Notice of Violation and Order, Docket Number 4631-10, issued to Jim Pace, Peter Moore and Bonnie Smith-Moore for the construction, installation, modifying or operation of any Public Water Supply System and any Sewerage System without permits which is a violation of Wyoming Statutes 35-11-301 (a)(v) and 35-11-301 (a)(iii). In addition, this facility discharged waste without a permit which is a violation of Wyoming Statute 35-11-301 (a)(i). Lastly, Grasslands MHP also operated a distribution system without the supervision of certified personnel, which is a violation of Wyoming Statute 35-11-302 (a)(iv). Jim Pace, Peter Moore and Bonnie Smith-Moore, Owners, are the legal representatives of the entity in question.

ANY APPEALS TO THE ENVIRONMENTAL QUALITY COUNCIL FROM THE ATTACHED ORDER MUST BE MADE IN WRITING WITHIN THE TEN (10) DAY LIMIT PRESCRIBED BY WYOMING STATUTE 35-11-701(c). Chapter 1, Section 3 of the Department of Environmental Quality Rules of Practice and Procedures set forth the requirements for the initiation of appeal proceedings. You are urged to review all of the provisions of the Rules of Practice and Procedures as they relate to this action. 
To appeal this Order and request a hearing, you must file two (2) copies of your written petition. The first hearing petition shall be mailed to the Chairman, Wyoming Environmental Quality Council; 122 West 25th Street; Herschler Building, 1st Floor West, Room 1714; Cheyenne, Wyoming 82002. The second petition shall be mailed to the Director, Wyoming Department of Environmental Quality; 122 West 25th Street; Herschler Building, 4th Floor West; Cheyenne, Wyoming 82002. Both petitions must be sent by certified mail return receipt requested.
