HEARING ORDER

The Environmental Quality Council will hear the Town of Alpine’s Motion to Intervene, Motion for Protective Order and SALL’s Motion to Strike on May 14, 2010 at the Wyoming State Library, 2800 Central Ave., Large Conference Room Cheyenne, Wyoming. The hearing will be heard at 1:00 P.M. All Parties shall have ten minutes each to present legal argument on the Motion to Intervene and ten minutes for the remaining motions.

In accordance with the DEQ Rules of Practice and Procedure, Chapter 1, Section 6, “Unless otherwise agreed to by the parties and consented to by the Council, all hearings, including all testimony, shall be reported verbatim by a competent reporter. The compensation of such reporter shall be paid as required by law and as ordered by the Council. The Council may direct any party or parties to assume the cost of the transcript.” If the Parties do not file a waiver to this section, the Parties should each pay one third of the costs of the transcript.

The Presiding Officer having reviewed the record and being fully advised in the premises,

IT IS HEREBY ORDERED

1. The hearing on the Town of Alpine’s Motion to Intervene, Motion for Protective Order and SALL’s Motion to Strike on May 14, 2010 at the Wyoming State Library, 2800 Central Ave., Large Conference Room Cheyenne, Wyoming. The Parties shall have ten minutes each to present legal argument on the Motion to Intervene and ten minutes for the remaining motions.
2. If the Parties have not filed a waiver on or before May 5, 2010 a court reporter will transcribe the hearing.
3. Each party shall assume one third the cost of the transcript and reporter.
