ORDER DISMISSING APPEAL WITHOUT PREJUDICE

The Wyoming Department of Environmental Quality and SALL Enterprises, LLC, have submitted a Joint Stipulation for Withdrawal and Voluntary Dismissal of Appeal Without Prejudice. The Town of Alpine, Wyoming, intervened in this matter and subsequently filed a purported objection to the permit issued by the Department of Environmental Quality on July 6, 2010. The matter was set for hearing on September 9, 2010. The Department of Environmental Quality appeared in person by and through its Counsel, Mr. Lucas Esch, SALL appeared personally by and through its principals and Counsel Gary L. Shockey and the Town of Alpine appeared via telephone through counsel Richard Rideout. The Town of Alpine, through counsel, withdrew its objection to the permit in this forum. The Environmental Quality Council ("EQC") having reviewed the Stipulated Motion and being otherwise informed in the premises, hereby finds good cause for granting the Motion of the State of Wyoming

Department of Environmental Quality and SALL to approve the stipulated settlement between them.

It is therefore ORDERED that the stipulation between the Department of Environmental Quality and SALL is APPROVED; that the Town of Alpine's withdrawal of its objection to the permit is acknowledged, and this matter is hereby DISMISSED without prejudice, with the State of Wyoming, Department of Environmental Quality and SALL to each bear their its own costs, expenses and attorney fees with respect to the appeal, permit issuance, stipulation, and all issues between them.


