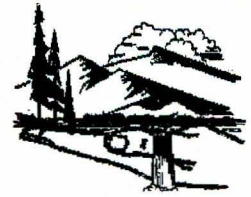

RE: Notice of Violation And Order, Docket Number 4968-12

Dear Mr. Yegen:

Attached is a Notice of Violation and Order, Docket Number 4968-12, for non-submittal of monitoring report data for eight (8) separate facilities (see **Table 1**) and failure to terminate non-producing injection wells within three (3) years of last injection. This is a violation of General Underground Injection Control Permit 5C5-2.


